Jean,

Per our discussion, I have attached a sketch of the revised grading and utility plan (focused on the walkway leading from the building to Industrial Way). As you will recall, the original plan depicted a wooden foot bridge over the existing roadside drainage ditch. Due to concerns that the railing for the bridge would be damaged or destroyed during street plowing operations, the bridge has been replaced with a culvert and continuation of the paved walkway. After speaking with David Margolis-Pineo, the proposed culvert will be reinforced concrete pipe to be consistent with the Technical Manual. At this time, there are no additional site elements proposed in the vicinity of the walkway. We hope that this modification will be considered a minor change and can be approved by planning staff. Let me know if you require additional information.
