Good Morning Peter,

Thank you for your response to my review comments. The retail use will be handled with a condition on the permit for future application requirements for a change of use to include a retail/public use component.

As for Nason's scope of work, it appears to be mostly plumbing related, not HVAC systems. A plumbing permit for internal water distribution and drainage is required, however this permit does not cover the cost of work, just fixture fees. The cost of such plumbing work should be included on the building permit. You can contact our office at 874-8703 or buildinginspections@portlandmaine.gov to pay the additional work fees. Electrical work is similarly charged and should be reflected on the building permit.

If an HVAC permit is required, this cost of work is calculated the same as a building permit. Nason Mechanical will need to determine if ventilation of the space adequately meets ASHRAE standards.

Questions:

- 1. Will grains be stored in the warehouse and if so, will there be any milling processes?
- 2. What is the access to the kettles or tanks, are they large enough to require over head access by a mezzanine or catwalk?

Hi Jeanie,

Thanks for getting back to me. As indicated in my voicemail, we are putting our on-premise retail plans on hold until we get up and running. There will only be 3 employees, myself included, at any given time within the premises. We still are planning to remove the wall to improve ease of movement in the facility and will revisit the retail plans next year after we are up and running. The building is an industrial park with ventilation, sprinklers, a fire alarm, and floor drains, and our property management company has repeatedly confirmed that the building meets all code requirements for the intended purpose (our units previously housed Maine Beer Company). Attached is the document from Nason Mechanical outlining the install procedures that will take place. These engineers are familiar with building code and permits and will pull the necessary ones during the install.
