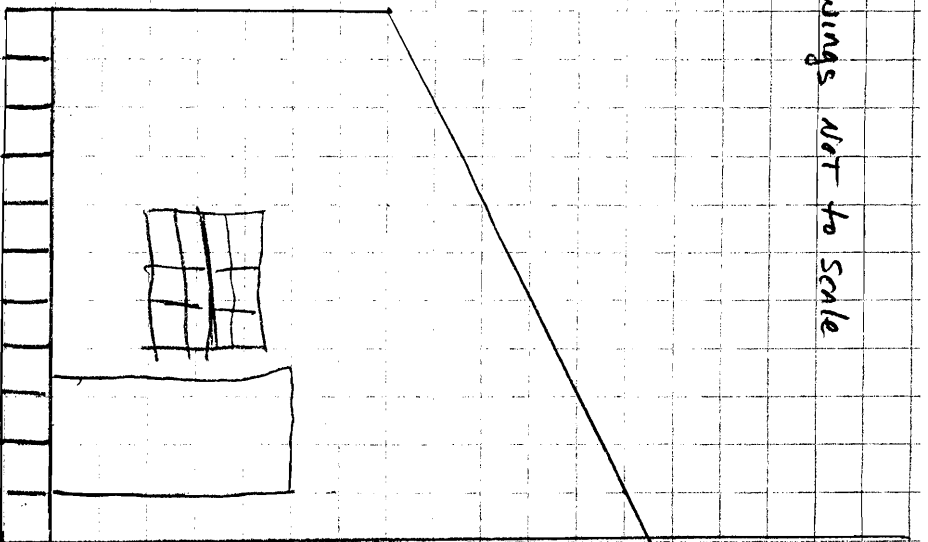

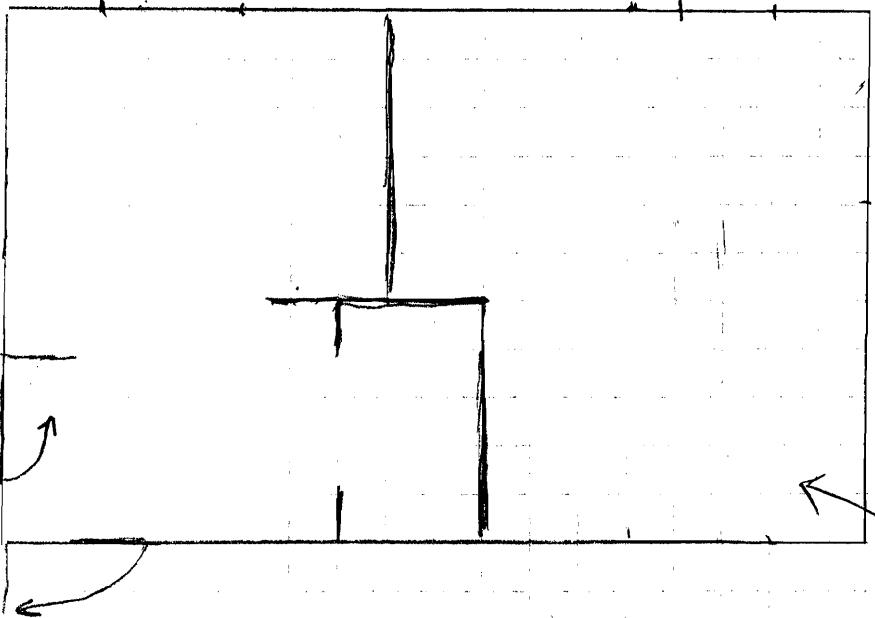
Rear of house
