

I am in the process of reviewing your application to place an above-ground pool at 54 Ninth Street. As you are likely aware, the City of Portland's zoning code requires that pools be located at least 10 feet from both the rear lot line and the side lot lines. The plan you submitted in support of your application depicts the setback from the rear lot line but I can't tell how far away from the side lot lines the pool will be. Can you please send along those measurements so I can determine whether your application meets the City's code requirements?
