DESCRIPTION OF SERVICES COVERED BY THIS CONTRACT:

Mechanical Services, Inc. will provide the labor and materials required to install the exhaust ductwork for your new paint booth. The duct has been sized for 13,965 CFM of air as specified in the documentation presented to us. The ductwork will be constructed of galvanized steel. The ductwork pathway shall be from the fan discharge and terminate outside to an area over the exterior man-door. We will provide the masonry services required for the hole in the exterior wall. We will provide a galvanized, opposed blade damper with electric actuator that shall close when the fan is not operating. It is understood that the wiring and interlocks for damper operation shall be by others. We will relocate the portion of plumbing drainage on the exterior wall to allow clear access for the duct exit.

COST FOR THIS PROPOSED WORK SHALL BE: Twelve Thousand Eight Hundred Sixty Six Dollars (\$12,866.00)
 The work shall be invoiced at completion. Any additional work will be performed upon written authorization and will be invoiced separately from work described above.

THE FOLLOWING WORK IS NOT INCLUDED IN THIS PROPOSAL:

- ◆ The handling or disposal of, or any costs associated with the handling or disposal of, hazardous materials, special waste, or mold, or any byproduct thereof.
- ◆ Wiring associated with the damper actuator.
- ◆ Unless specifically provided for herein, Mechanical Services, Inc. is not responsible for the structural integrity of any portion or aspect of the building where this work will be performed, including the ability of the structure to support the load of the equipment being installed.
- ◆ All extra service to correct problems found during work described above.

WARRANTY: For a period of one year from the date of start-up, all parts and labor for new equipment provided by Mechanical Services, Inc.
