Hi Matthew,

I am reviewing your amendment plans and will need some additional information and clarification in order to proceed and approve. Please see the attachments and following questions:

- 1. Your description states that you would like to open up the stairwell and partially remove an existing wall. Can you please clarify this, is the wall you are partially removing the full wall that currently encloses the stair, or are you also removing another wall? If so, please provide a first floor plan view that can clearly show where this is being done?
- 2. A plan view of the stairs would help to show the location of the new guard location in relation to the stair run and where it terminates.
- 3. I think I figured out the 2 drawings you sent, that there will be a new guard at the first 2 risers of the stairs, thus the 15". It is confusing as the width shows 15" but the balustrade looks much longer.
- 4. What is currently at the opposite side of the 2 steps? Is there a wall or is it open? Will there be a quardrail here as well? Again, a plan view will help clarify this.






