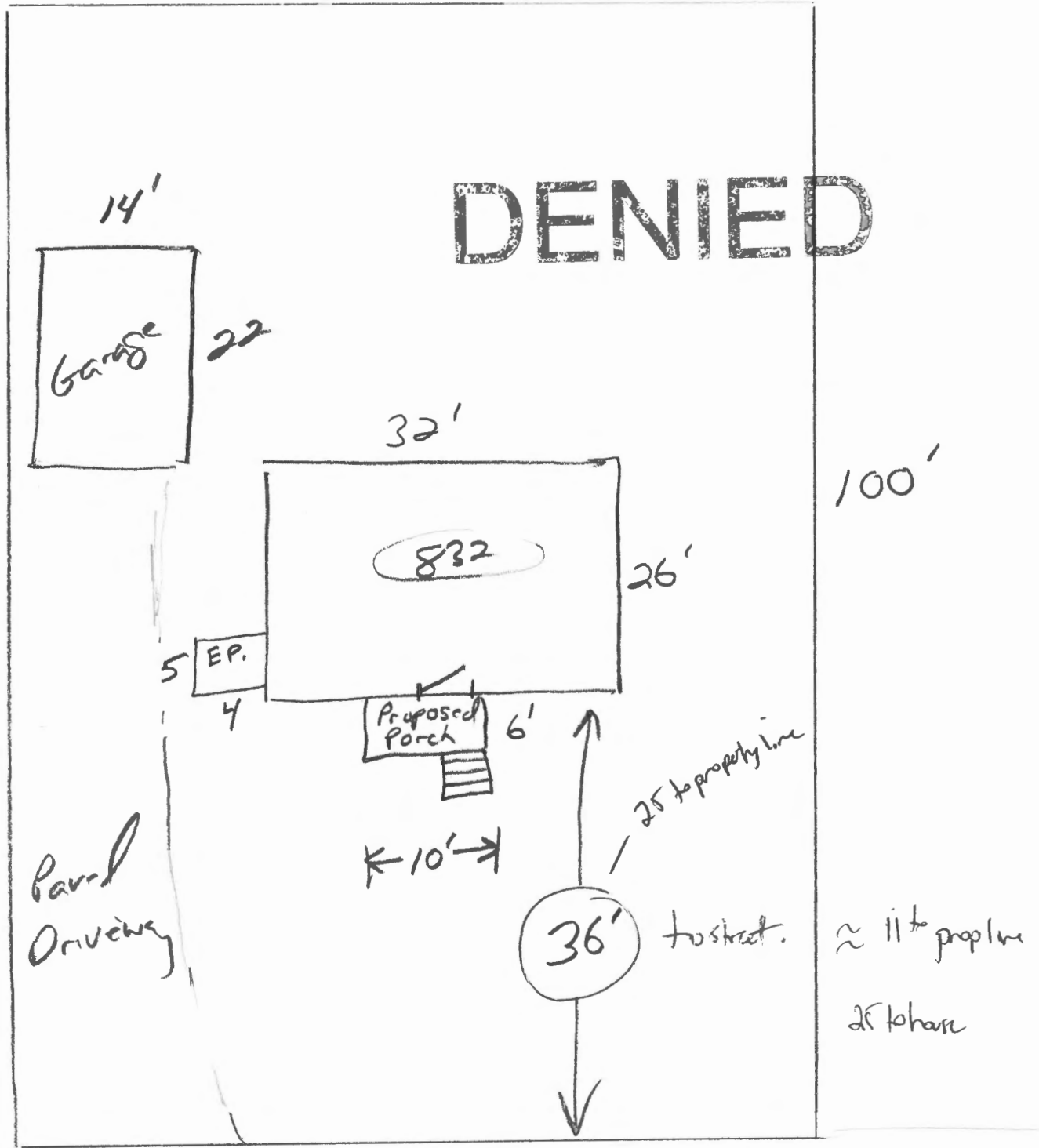

Plot Plan

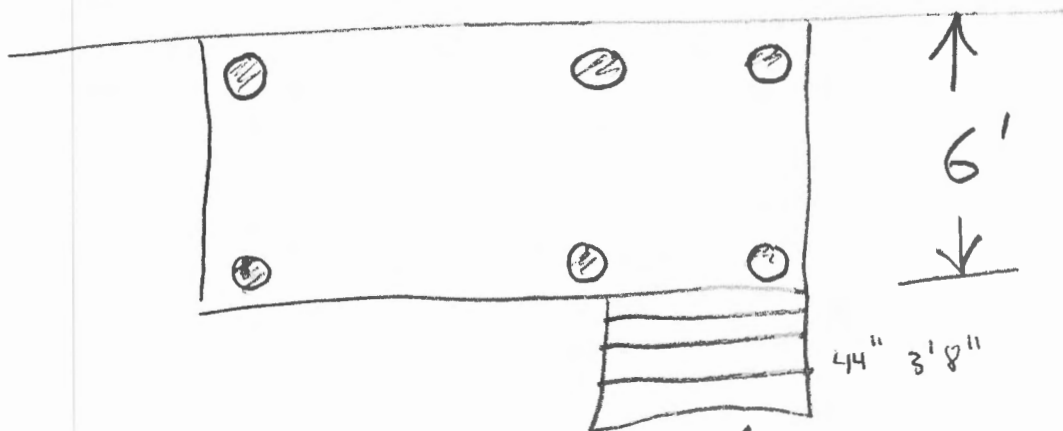
