#### 1. New Business:

##### A. Conditional Use Appeal:

140 Pennell Street: Dana Cunningham, owner, Tax Map 347, Block A, Lots 008 through 016, R-3 Residential Zone: The applicant is seeking a Conditional Use Appeal under Section 14-88(a)(2) to add an accessory dwelling unit to his existing single-family home. Representing the appeal is the owner. *The board of appeals voted 5-0 to grant the Conditional Use Appeal to add an accessory dwelling unit to the single-family home.*

##### B. Practical Difficulty Variance Appeal:

122 Anderson Street: Anderson Street Realty, LLC, owner, Tax Map 10, Block H, Lots 005 and 008 and Tax Map 12, Block N, Lot 001, I-Lb Industrial Zone: The applicant is seeking a Practical Difficulty Variance to reduce the pavement setback from the required 15 feet [Section 14-234(h)] to 0 feet. Representing the appeal is Douglas Cardente, manager for the owner. *The board of appeals voted 5-0 to deny the Practical Difficulty Variance Appeal to reduce the pavement setback.*

##### C. Conditional Use Appeal:

77 William Street: Eletherios Minas, owner, Tax Map 117, Block D, Lot 015, R-5 Residential Zone: The applicant is seeking a Conditional Use Appeal under Section 14-118(a)(5) to add one dwelling unit to his existing two-family home. Representing the appeal is the owner and Alexander Lehnen, owner's agent. *The board of appeals voted 5-0 to grant the Conditional Use Appeal to add one dwelling unit to the two-family home.*

#### 2. Other Business:

A. Election of Chair and Secretary for the Zoning Board of Appeals – *Kent Avery was re-elected chair and Donna Katsiaficas was re-elected secretary for the Zoning Board of Appeals.*
