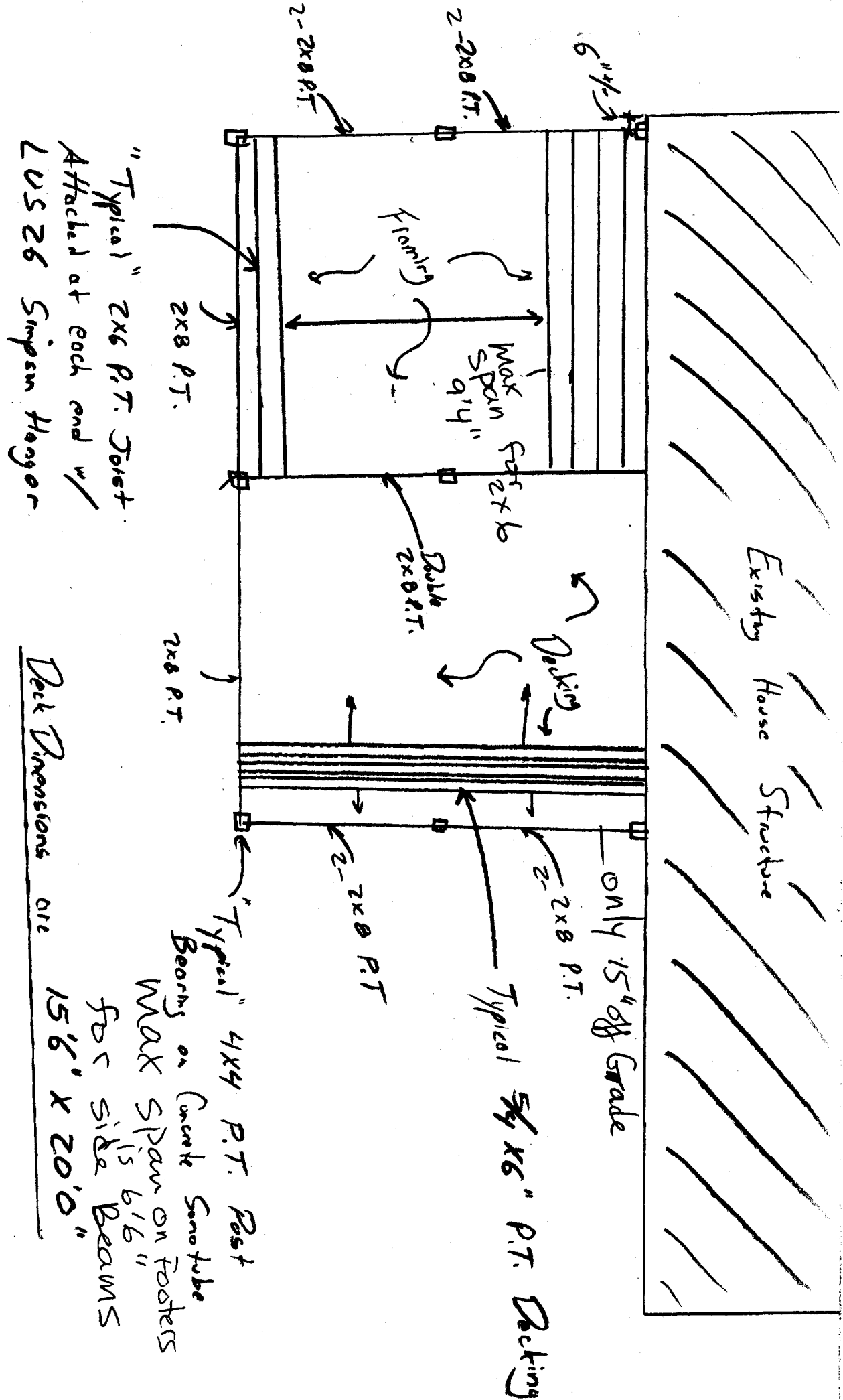

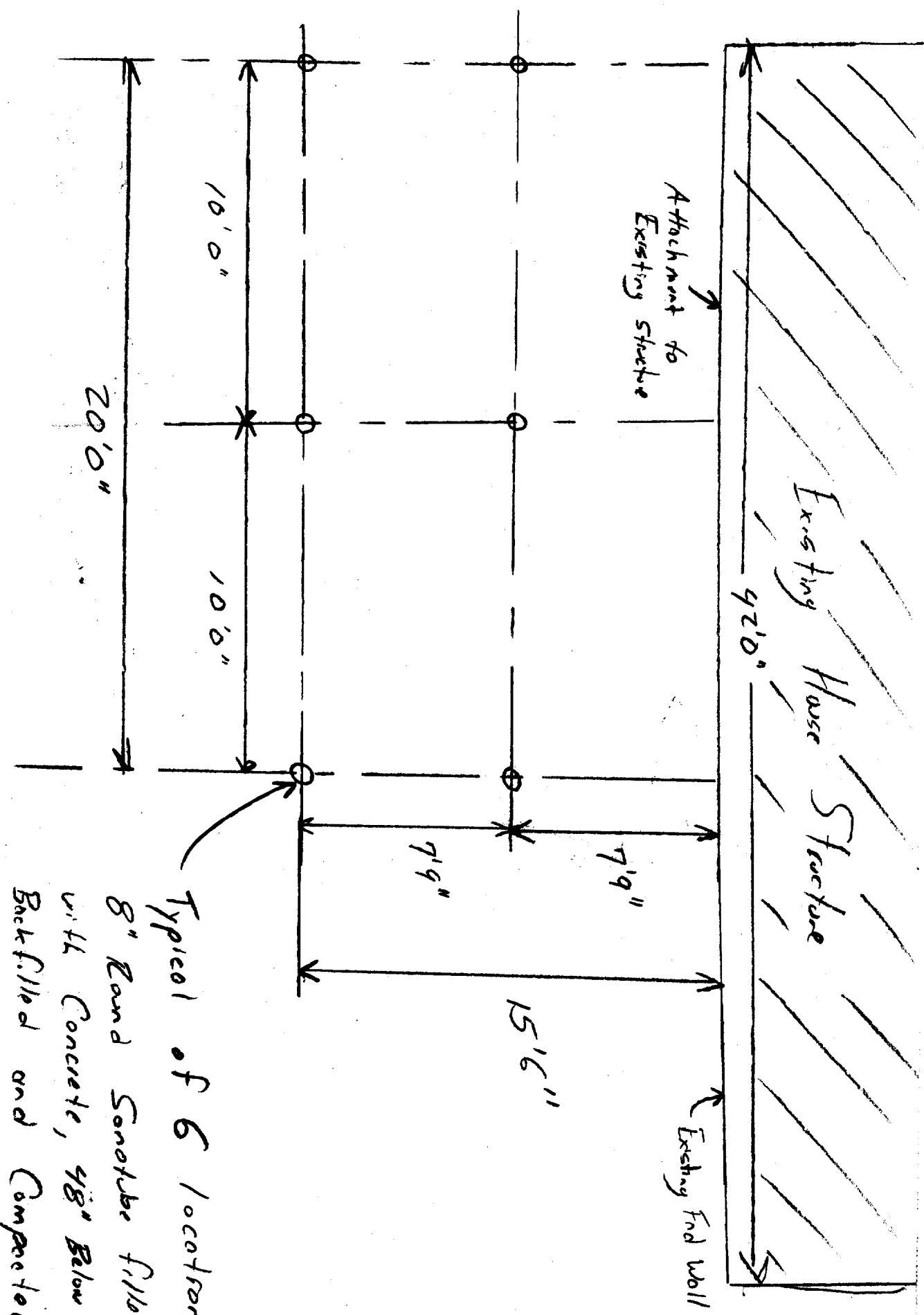

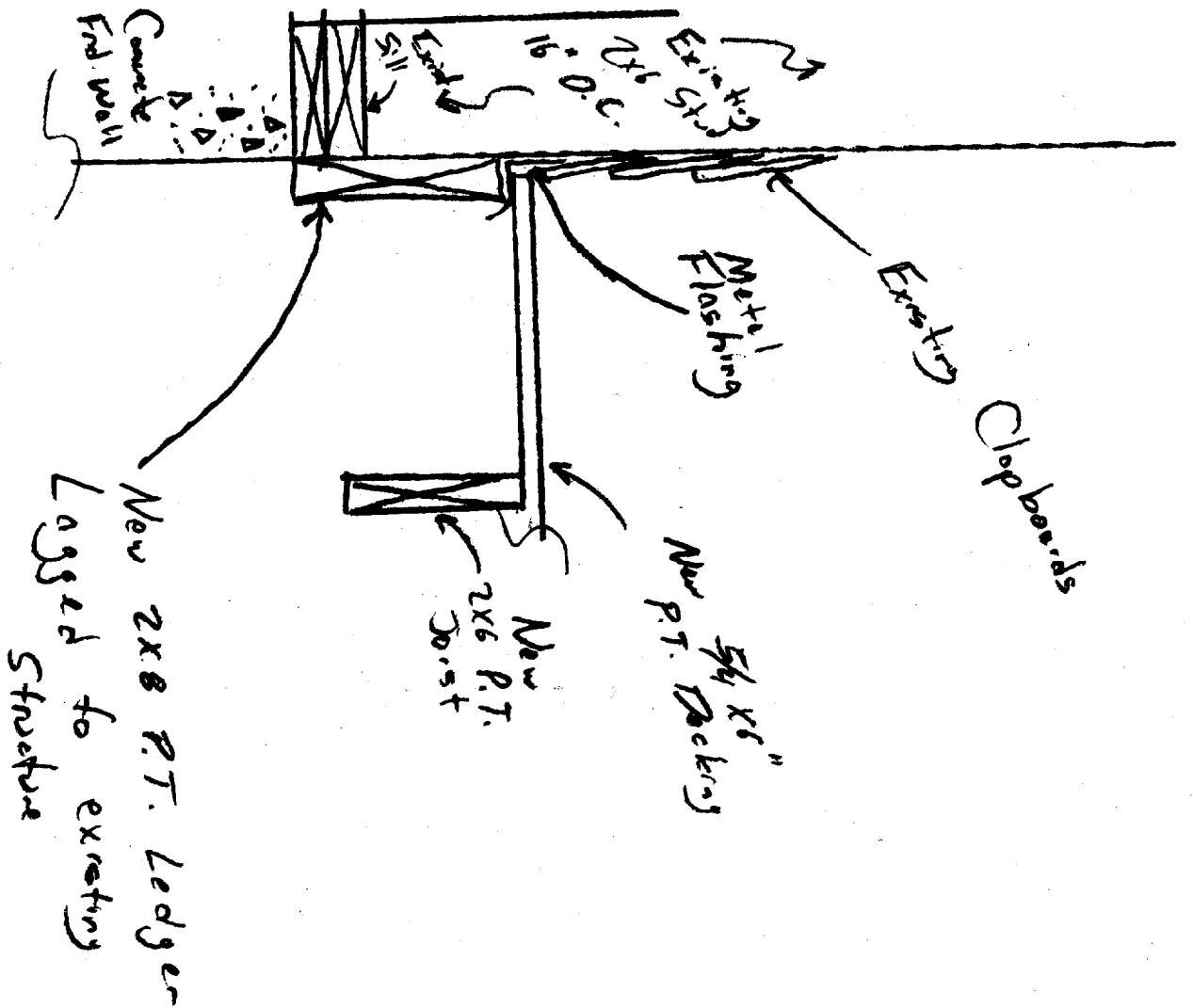

New Deck Foundation Plan

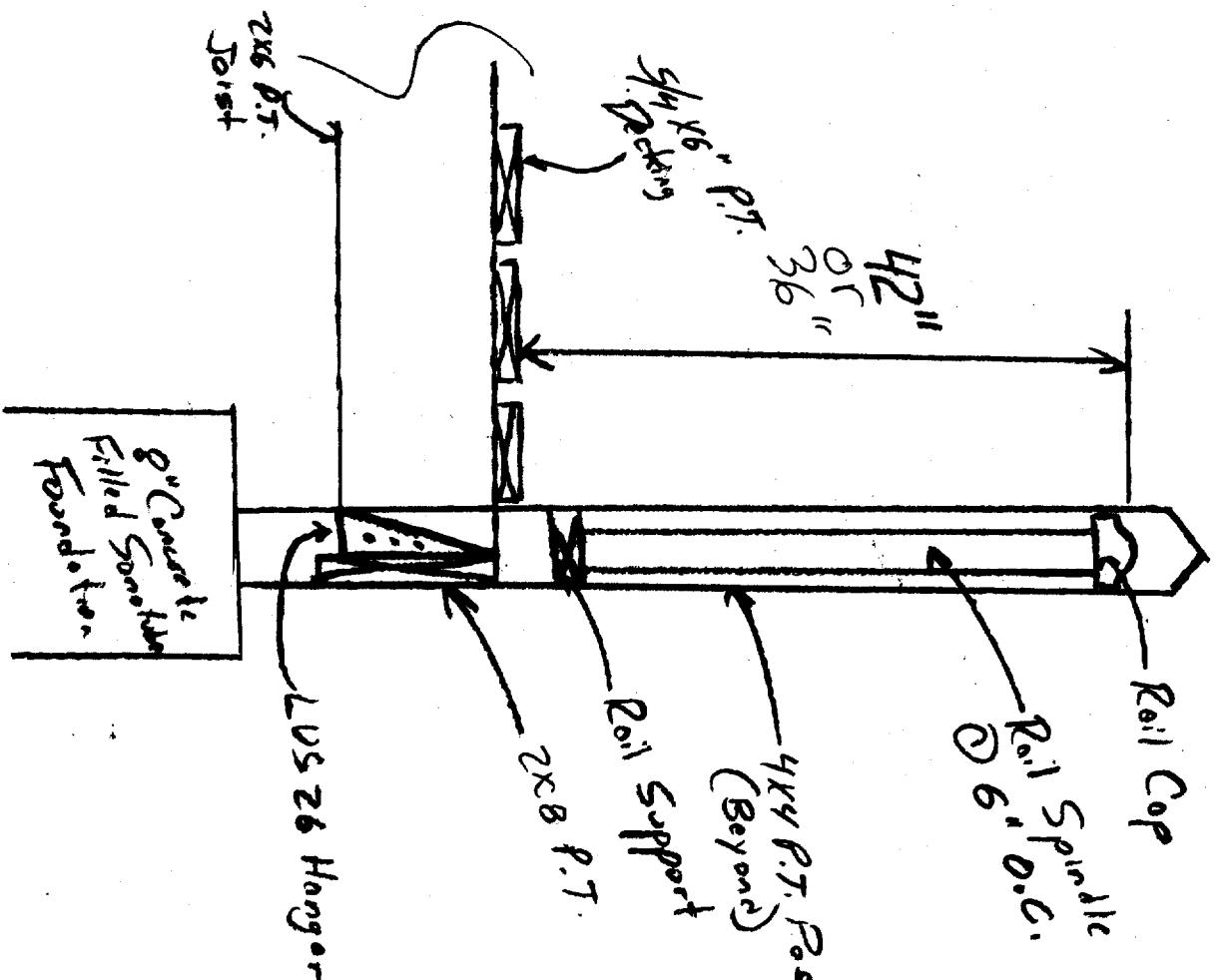
