This conveyance is SUBJECT TO an easement from Maine National Bank as Trustee to Portland Water District dated April 23, 1974 and recorded in said Registry of Deeds in Book 3535, Page 205.

This conveyance is made SUBJECT TO applicable zoning ordinances of the City of Portland.

This conveyance is made TOGETHER WITH and SUBJECT TO the rights, benefits, restrictions, terms, and conditions of a certain side track construction and maintenance agreement dated March 11, 1974 between Portland Terminal Company and Riverside Building Company, also known as Riverside Building Co.
