


CORRECTIVE DEED

EXHIBIT A

A certain lot or parcel of land with the improvements thereon on the northeasterly side of Washington Avenue in the City of Portland, County of Cumberland, State of Maine as shown on the Existing Conditions Survey of Jimino Property on Washington Avenue by Sebago Technics Inc (Project number 15095) last dated August 7, 2015 and being more particularly bounded and described as follows:

Beginning at a 5/8 inch iron rebar to be set on the northeasterly sideline of Washington Avenue and the southerly corner of land now or formerly of Philip J. Foley and Trina A. Lindahl as described in deed book 11983, page 171;

Thence N 59°-01'-40" E along the southeasterly sideline of said Foley and Lindahl, a distance of 176.51 feet to a 5/8 inch iron rebar to be set;

Thence N 36°-55'-20" W along the northeasterly sideline of said Foley and Lindahl, a distance of 95.00 feet to a 5/8" iron rebar to be set on the southeasterly sideline of land now or formerly of the City of Portland as described in deed book 12842, page 401;

Thence N 58°-23'-40" E along the southeasterly sideline of said City of Portland, a distance of 295.20 feet to a 1.5 inch Iron pipe on the southerly sideline of land now or formerly of Auburn Terrace Associates as described in deed book 3191, page 227;

Thence S 31°-33'-18" E along the southerly sideline of said Auburn Terrace and the southwesterly sideline of land now or formerly of Brookfield Property Management LLC as described in deed book 30546, page 54, a distance of 348.90 feet to a 1.5 inch iron pipe at the northwesterly corner of land now or formerly of Shana M. Walsh as described in deed book 31068, page 96;

Thence S 62°-17'-10" W along the westerly sideline of said Walsh, a distance of 270.00 feet to a 5/8 inch iron rebar to be set;

Thence N 35°-55'-46" W, a distance of 186.48 feet to a 5/8 inch iron rebar to be set being 50.00 feet from when measured perpendicular to the first described course;

Thence S 59°-01'-40" W being 50.00 feet from the first described course, , a distance of 158.78 feet to a 5/8 inch iron rebar to be set on the northeasterly sideline of said Washington Avenue;

Thence N 53°-41'-49" W along the northeasterly sideline of said Washington Avenue, a distance of 54.21 feet to the Point of Beginning.

The total area of the above-described parcel is approximately 104,028 Square Feet.

Meaning and intending to redescribe a parcel of land described in a deed to Michael R. Jimino Revocable Living Trust and the Mary Ann Jimino Revocable Living Trust recorded in the Cumberland County Registry of Deeds in Book 32326, Page 254, now being the result of a boundary survey.

Bearings herein are based on a Grid North.
