



Gorham Sand & Gravel was contracted by Stan Towle to complete the earthwork for a private residence located at 1643 Washington Avenue. Mr. Towle contacted GSG requesting any information we may have in regards to the inspection of the foundation by the City of Portland.

Jim Roberts our foreman on the project remembered speaking with Doug Morin on site, but could not recall if Mr. Morin was on site for a sewer or foundation inspection.

Mr. Roberts had in his field book that the 4' frost wall foundation was backfilled with granular material, which was brought up in lifts and compacted. As the design was slab on grade construction, the foundation was not damp proofed, and perimeter drains were not required.

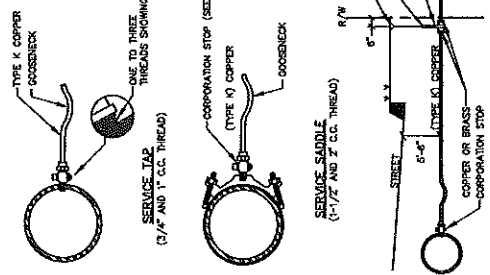




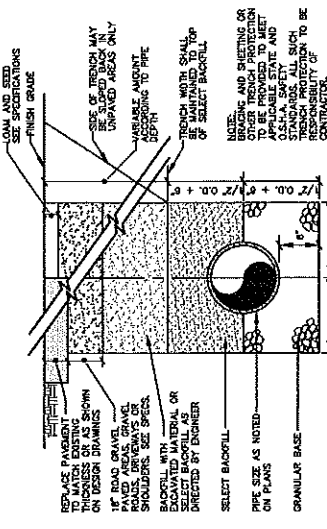

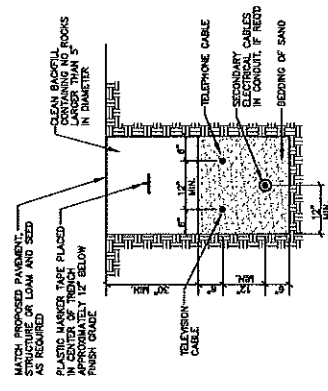


**TYPICAL SERVICE CONNECTION**

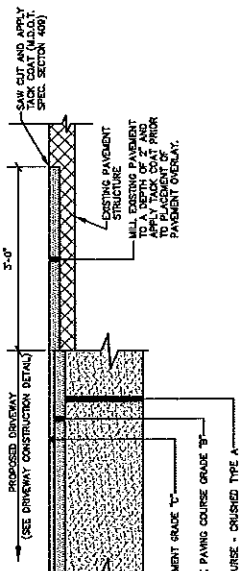

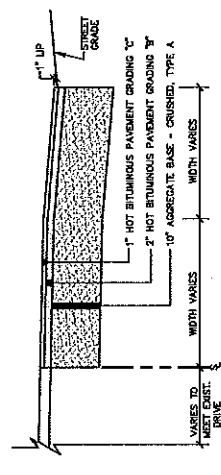

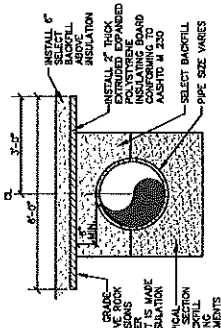
**TYPICAL UNDERGROUND CABLE INSTALLATION**

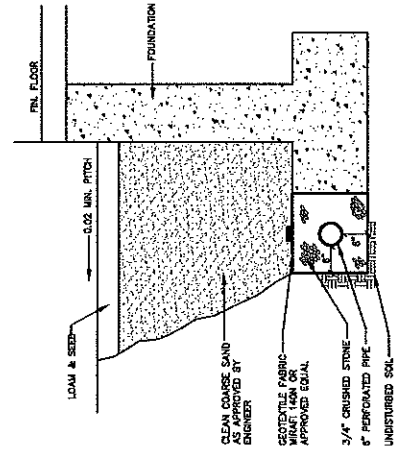
**TYPICAL PAVEMENT JOINT**
