To Whom It May Concern,

I am in receipt of a request for determination from Paragon Management LLC, the property managers for Oakpoint LLC located at 94 Auburn Street, Portland, Maine. The property at 94 Auburn Street is located within two different zones. The principal zone that includes the entire building is located in the B-1 Neighborhood Business Zone. The rear of the property where most of the accessory parking is located is within an R-3 residential zone.

It is my understanding that administrative offices for a home healthcare company wants to locate in the 94 Auburn Street building. Professional offices, as defined in section 14-47 (definitions,) are a listed permitted use in the B-1 zone. Offices for a healthcare company would be considered a professional office use.

Please be advised that this determination does not substitute for the requirement of building permit application for tenant fit-up and/or a change of use permit for this proposed use.


