
To Whom It May Concern:

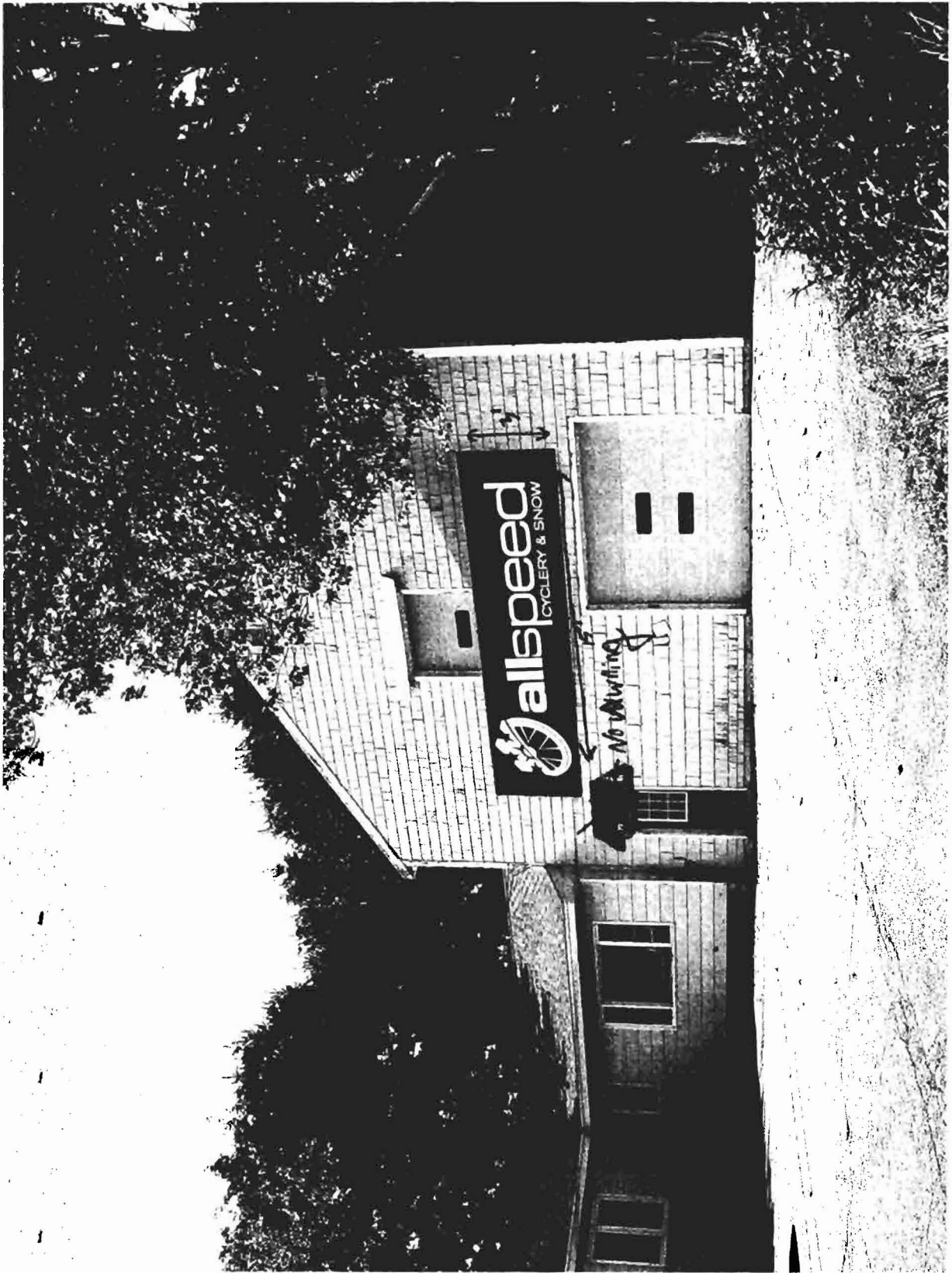

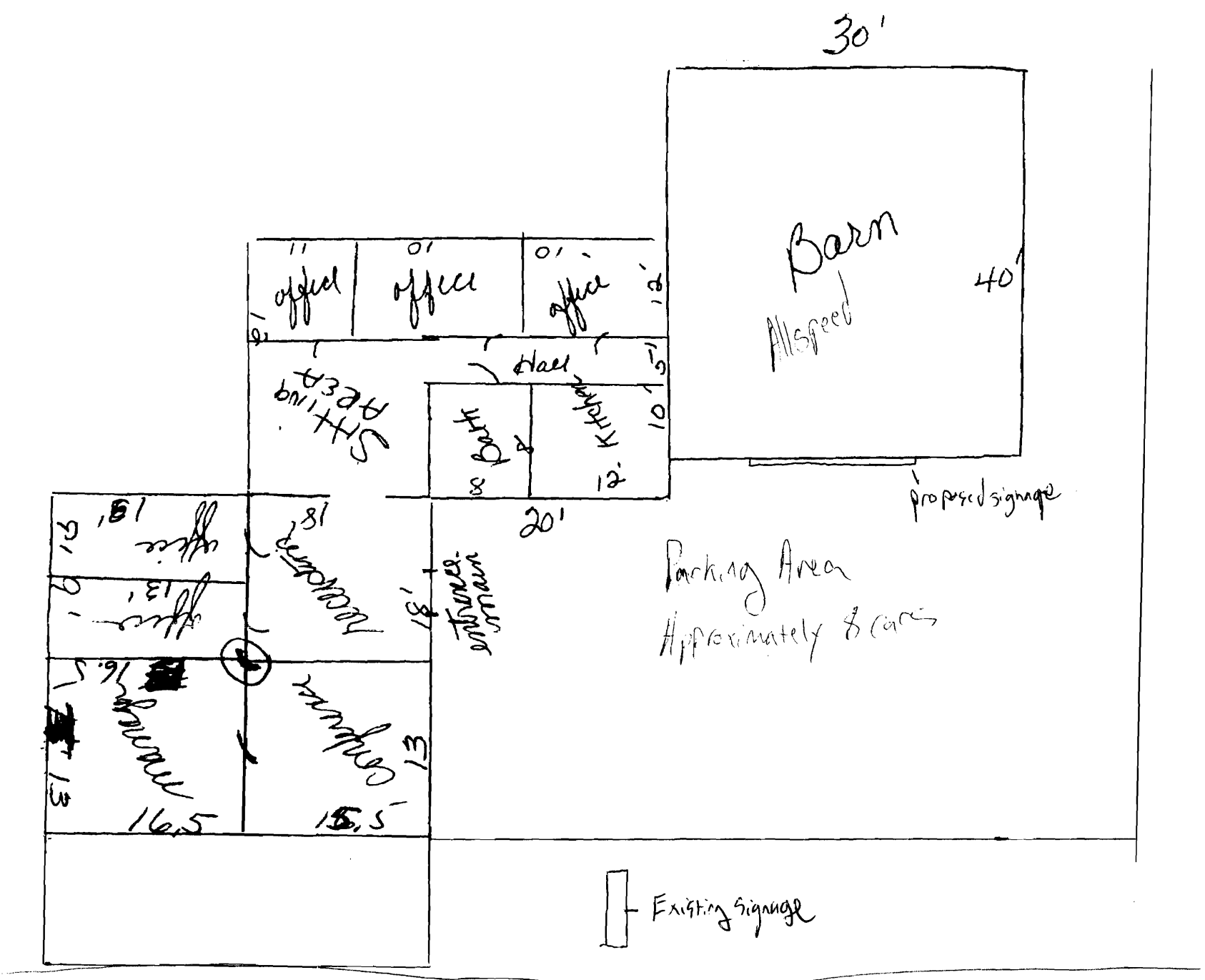
Allspeed Cyclery & Snow also has my permission to install additional signage to include awnings, per the city code guidelines, on the front of the barn which is their leased space.
