<ol style="list-style-type: none"> 1) Section R105.2 of the International Residential Code states that storage structures 200 square feet or less are exempt from building code review. This structure has not been reviewed for construction or safety compliance under the adopted Building Codes. This does not grant authorization for any work to be done in any manner in violation of the provisions of this code. 2) This property shall remain a single family dwelling. Any change of use shall require a separate permit application for review and approval. 3) The height of the shed shall not exceed 18 feet as measured from grade to ridge. 4) Separate permits are required for any electrical, plumbing, sprinkler, fire alarm, HVAC systems, heating appliances, including pellet/wood stoves, commercial hood exhaust systems, fire suppression and fuel tanks. Separate plans may need to be submitted for approval as a part of this process. 5) This is being issued with the understanding that as a fast track, the owner is responsible for scheduling inspections for the work being done and the inspector may require modifications to the work that has been completed if it does not meet code. 6) This permit is being approved on the basis of plans submitted. Any deviations shall require a separate approval before starting that work.
