Beginning at a point in the easterly street line of Longview Drive, as laid out by the City Council November 19, 1962, said point being distant 717.04 feet northeasterly from the first angle in Longview Drive easterly of Auburn Street;

thence northeasterly and making an included angle of 178°41' through the west with the southeasterly direction of the said easterly side line of Longview Drive, a distance of 350.01 feet to a point.

Said street to be fifty (50) feet wide and to lie wholly on the westerly side of the above described line, as shown on the Public Works Department plan of Longview Drive.

Beginning at a point in the southerly side line of Abby Lane, said point being distant 480.67 feet along the said southerly side line from its intersection with the easterly side line of Summit Street and being also the easterly terminus of Abby Lane as laid out and accepted by the City Council January 15, 1962;

thence easterly in a prolongation in a straight line of the said southerly side line of Abby Lane, a distance of 392.40 feet to a point;

thence northeasterly on a curve to the southeast with a radius of 50.00 feet and tangent to the last described course, a distance measured on the arc of 62.28 feet to a point;

thence southeasterly on a course tangent to the last described curve, a distance of 778.03 feet to a point and an intersection with the northerly side line of Curtis Road.

Said street to be fifty (50) feet wide and to lie wholly on the northerly side of the above described line, as shown on the Public Works Department plan of Abby Lane.
