KNOW ALL BY THESE PRESENTS, that I, **IRENE H. TOWLE**, of the City of Portland, County of Cumberland, and State of Maine, for consideration paid, **GRANT** to **PAUL B. COURNOYER** and **KYMBERLEY T. COURNOYER**, both of the City of Portland, County of Cumberland and State of Maine, whose mailing address is 27 Merrymeeting Drive, Portland, Maine 04103, with **WARRANTY COVENANTS**, as **joint tenants**, certain real property comprising **Unit No. 24, Building G**, in Fallbrook, A Condominium, located in the City of Portland, County of Cumberland and State of Maine, more particularly described as follows:

Unit No. 24, Building G, in Fallbrook, A Condominium located in the City of Portland, County of Cumberland and State of Maine, the Declaration of which is dated April 20, 1989, recorded in the Cumberland County Registry of Deeds in Book 8730, Page 206, as amended of record.

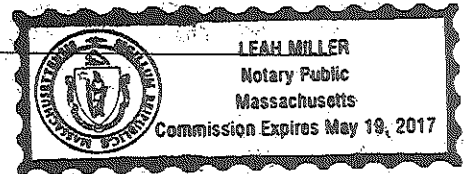
