Thank you for sending the final detail sheet for this project that includes the dumpster enclosure. I have copied this to Malia and Kyle as all of the other submissions have come through them to me.

I would note that the detail for the bollard does not match the one that is on the approved plan C5 (attached)- not a big issue but where are the bollards being located- is it really necessary for them to be painted bright yellow and be 4 feet high? The bollard detail on the A9 sheet is for the bollards within the trash enclosure to protect the CMU from damage and is out of public view.

Regarding the dumpster detail- the objective is for the dumpster to be screened and hidden if possible- this is an urban area with lots of pedestrians and nearby buildings/users so it should not be highlighted with yellow posts etc. **Dumpsters will be screened with the CMU wall and metal gates. Steel supporting the gates will be painted a color to match the building color, Sherwin Williams 7069 – 'Iron Ore'.**

What is the material on the sides and back? 8x8x16 split face CMU on the sides and back of the enclosure.

Could you please revise to confirm the material on the side and back of the enclosure and remove at least some of the bright yellow and if possible introduce some planting on the side facing Washington Avenue. **Addition of planting to the side facing**

Washington Ave. will consist of a 4 foot wide island and will include three (3) Techny Arvorvitae 48 inches in height.
