Thanks for getting to this quickly. We were assuming two road frontages at this site, which we thought would allow 3 signs. The side road may not be an official city road, but it is a pretty active entrance and exit way to other shops. Would this not allow for a 3<sup>rd</sup> sign? If not, then we'll advise the customer to remove the sign on the "Left Side" elevation. (Would both the bell and "Taco Bell" letters need to come down, or can the bell stay up?)
