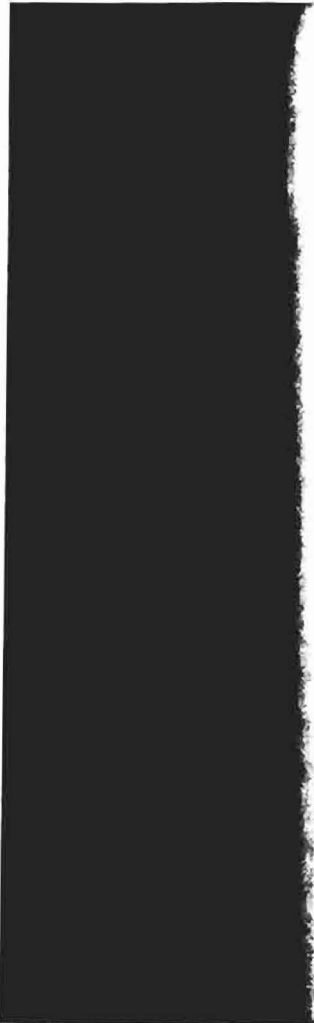

A Pre-construction Meeting will take place upon receipt of your building permit.



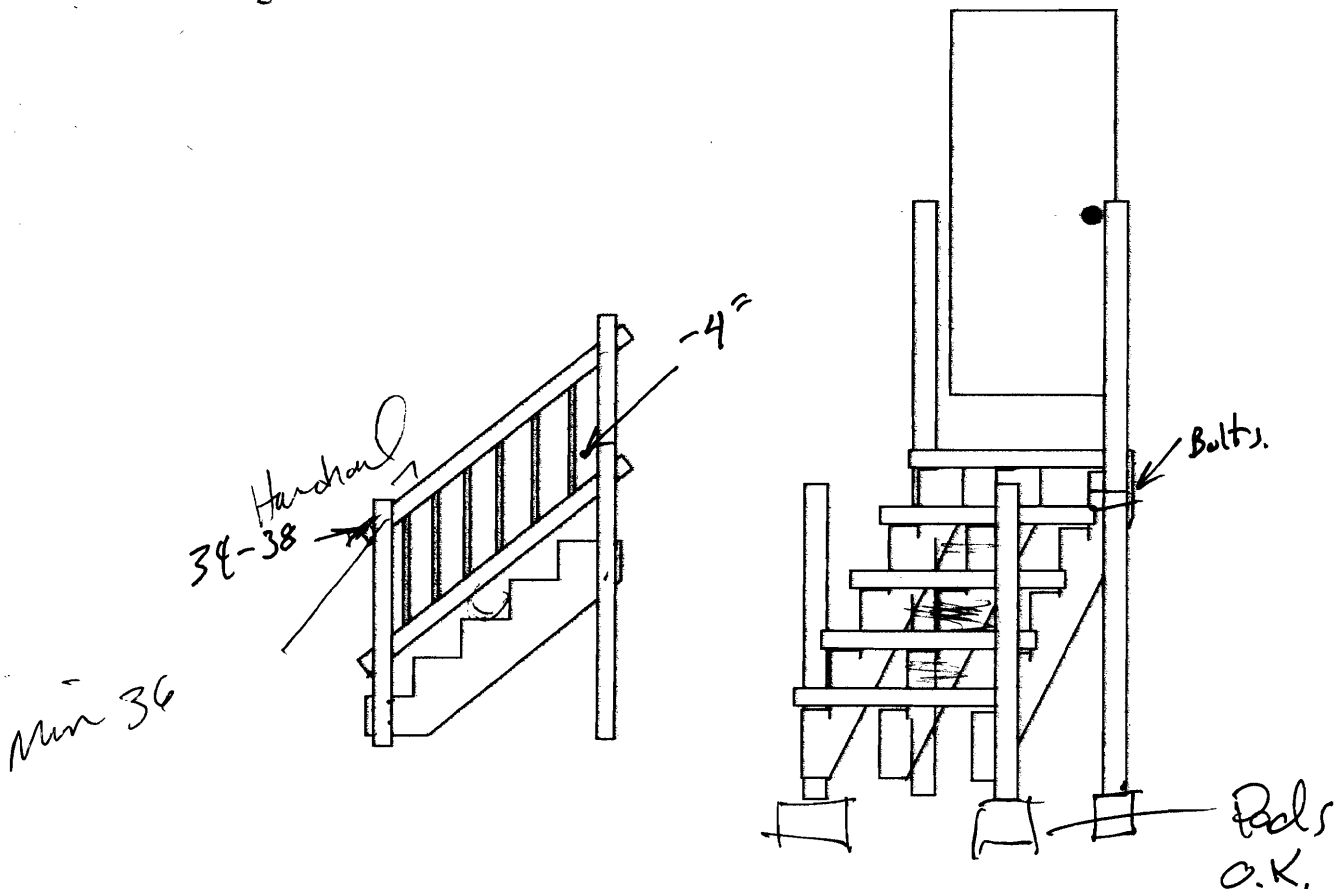

PERMIT DESCRIPTION

We are planning to replace the exterior stairway on an ongoing rehab project.

Stair Detail:

- 44" wide pressure treated stairs, 36" finished tread area. The total height of the stairs will be 35"
- 3 five step stringers with a 7" rise and 10" run and they will be spaced 18" apart
- Stair treads will be 5/4x6 PT with a 1/2" over hang over stringers for nosing.
- The railings will be on both right and left sides of the steps.
- The railing will be built out of PT 4x4 posts driven one foot in the ground and nailed to the stringers. It will have 2x2 PT balusters spaced 4" apart and it will have a graspable top rail.
- The top of the stringers will be screwed into a 5/4 PT plate which is lag bolted into the house with three 3" lag bolts spaced 10" apart
- The bottom of the stringers will be supported by solid patio blocks 4" thick, 8 inches wide, and 16 inches long

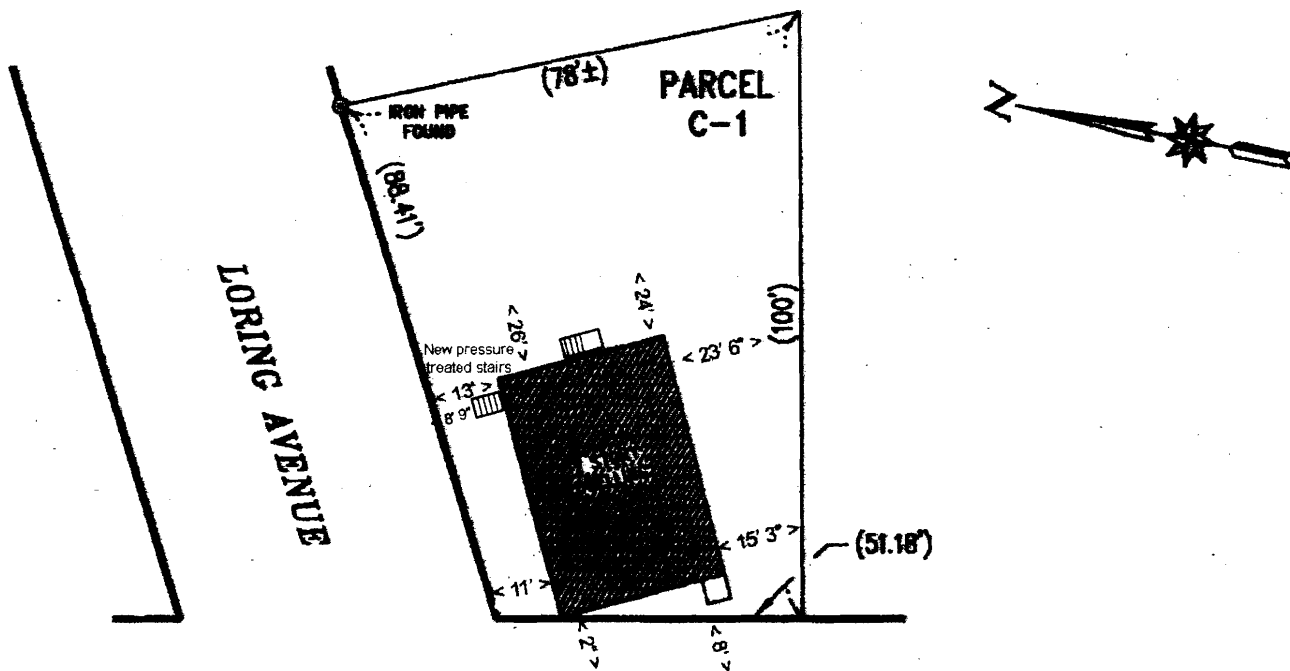
