


LOCATION PLAN

- 3. ALL BOOK AND PAGE REFERENCES REFER TO THE CUMBERLAND COUNTY REGISTRY
- 4. PARCEL TAX MAP REFERENCE: CITY OF PORTLAND, MAP 427, LOT 10 AND MAP
- 5. TOTAL EXISTING AREA OF PARCEL MAP 427, LOT 10 IS 6689 SQUARE FEET & PARCEL MAP 427, LOT 11 IS 6010 SQUARE FEET.
- 6. ALL BEARINGS ARE REFERENCED TO MAINE STATE PLANE WEST ZONE NAD83 PER CITY OF PORTLAND MONUMENTS, MAGNETIC DECLINATION IS 13°15'52" BASED ON
- 7. COORDINATES FOR THIS PLAN BASED ON POINTS PROVIDED BY CITY OF PORTLAND BASE POINT L742-2-4 N.309844.8640' E.2929450.3490' AZ. POINT L742-9-112 N.310613.2580' E.2929992.0940'
- 8. ELEVATIONS SHOWN ARE TIED TO CITY OF PORTLAND DATUM (NGVD 1929) PER "BM HODGINS", MONBOLT ON 3' O/S VERANDA STREET AT 1ST ANGLE POINT SWLY OF HODGINS STREET ELEVATION: 22.95.
- 9. THIS PARCEL IS NOT LOCATED IN A SPECIAL FLOOD HAZARD ZONE AS DEPICTED ON FEMA FLOOD PANEL #230051-7C
- 10. THE LOCATION, SIZE, AND DEPTH OF UNDERGROUND UTILITY LINES, TANKS, AND OR
- 11. THE BOUNDARY LINES OF THE SURVEYED PREMISES (LOCUS PARCEL) ARE BASED ON FOUND IRON PINS ALONG DALTON STREET AND ALONG THE SOUTHWESTERLY LINE OF THE LOCUS PARCEL. THESE PINS WERE FOUND TO MATCH RELATIVELY WELL TO THE ORIGINAL SUBDIVISION PLAN AND WERE HELD. THE BOUNDARY LINES AS SURVEYED VARY FROM THE LINES AS DEPICTED ON PLAN REFERENCE A BELOW BY 0.67 FEET TO THE SOUTHEAST. NO PINS WERE FOUND SET FROM PLAN
- 12. THE LOCUS DEED DESCRIPTION FOUND IN BOOK 31594, PAGE 160 CONTAINS A NUMBER OF ERRORS, ADDITIONS, AND OMISSIONS. A CLOSED FIGURE CANNOT BE CREATED FROM THE DESCRIPTION AS WRITTEN. HOWEVER, IT IS CLEAR FROM THIS DEED THAT THE INTENT WAS TO DESCRIBE THE PARCEL AS DEPICTION ON PLAN REFERENCE A. THE GEOMETRY OF THIS LOT WAS TAKEN AS SHOWN ON SAID PLAN.
