1. Clarify why one of the two fire walls shows an extension beyond the exterior wall and the other does not? Provide continuity on all plan sheets. Reference the code section this is associated with in the code analysis.

Please note that we have revised the firewalls extensions on A0.1 to be consistent to 706.5.2

2. The legend looks to be incomplete and missing some wall components. Please revise legend to include all wall types with definitions.

Please note that we have included the missing information on the wall legend. Note this has been revised on sheets A0.1 - A0.5.

3. There is no sheet A7.1. Clarify what plan sheet you are referencing.

Please see revised sheet A7.1b with missing wall type reference "J" and "P".

4. Provide definitions on legend throughout egress floor plans.

Please see missing wall legend on sheets A0.1 – A0.4.

5. This exiting table is referencing the incorrect floor level. Please revise.

6. There are no notes referenced on this plan sheet. Please reference notes. Area of Refuge.

7. Include in statement of special inspections requirements per Section 909 Smoke Control Systems.

8. Please bubble all responses to plan review comments or label as previously done with revisions.

9. Please provide copy of state fire marshal permit.

10. Provide plumbing fixture calculations per the 2009 UPC. Provide ADA compliance calculations and reference portion of ADA code that is applicable.

 Reference section of code associated with firewall. Clarify how the 2 hour wall separation was determined. In the beginning of the code analysis, sections and exceptions have been referenced. Provide that type and level of detail of information throughout the entire code analysis. Reference horizontal continuity, exterior walls, vertical continuity, etc.

12. Provide similar information regarding atrium code analysis requirements and details.

13. Review and re-reference. Section 718.4 is for Fire –Resistance Requirements for Plaster and not draftstopping.

14. Label all floor and wall assemblies. The floor assembly N for the roof deck or J for elevator shaft is not called off. Please revise.

Please note that A7.1b has had the missing assemblies added.
