



EXHIBIT A

A certain lot or parcel of land situated on the westerly side of Ocean Avenue and on the southerly side of Ledgewood Drive in the City of Portland, County of Cumberland, State of Maine bounded and described as follows:

Beginning at a point at the intersection of the westerly sideline of Ocean Avenue with the southerly sideline of Ledgewood Drive said southerly sideline of Ledgewoods Drive also being the town line between Portland and Falmouth. Thence by the following courses and distances:

- 1) S 09°-07'-16" W along Ocean Avenue a distance of 116.40 feet to an iron pin set at land now or formerly of Peter L. & Irene E. Fulton as recorded in the Cumberland County Registry of Deeds in Book 23862, Page 281.
- 2) N 78°-19'-40" W along land of said Fulton a distance of 85.00 feet to an iron pin set.
- 3) S 09°-07'-16" W along land of said Fulton a distance of 100.00 feet an iron pin found at land now or formerly of Patricia A. & William C. Tebbetts as recorded in the said Registry in Book 17830, Page 229.
- 4) N 78°-20'-15" W along land of said Tebbetts a distance of 63.75 feet to a point at land to be retained by TPO Properties LLC.
- 5) N 11°-50'-30" E along land to be retained and land now or formerly of Regina L. Flaherty & Scott E. Booth as recorded in the said Registry in Book 28674, Page 183 a distance of 98.81 feet to an iron pin found.
- 6) N 78°-09'-30" W along land of said Flaherty & Booth a distance of 24.00 feet to an iron pin found.
- 7) N 11°-50'-30" E along land of said Flaherty & Booth a distance of 118.00 feet to an iron pin found on the southerly sideline of Ledgewood Drive and on said town line.
- 8) S 78°-05'-12" E along the southerly sideline of Ledgewood Drive and town line a distance of 162.48 feet to the point of beginning.
