All of the following information is required anust be submitted. Checking off each item as you prepare your application package will ere your package is complete and will help to expedite the permitting process.

The Maine Home Construction Contracts Act require at any home construction or repair work for more than \$3000 in materials or labor must be based on a written contractless the parties agree to exempt themselves. ### One complete application packet includes:

The application page filled out in its entirely and signed, e mail address required

A plot plan detailing the shape and dimension of the property, footprint of the existing and proposed structure(s), and the distance from the actual property lines on all 4 sides of all structures. (Structures include decks, porches; bow windows, cantilever sections and roof overhangs, sheds, pools, garages and any other accessory structures must be shown with dimensions if not to scale.)

All documents and plans to be submitted as electronic files (PDF format as required)

Proof of ownership is required if it is inconsistent with the assessor's records

Supply <u>one</u> of the following which includes the length, width and height of the shed: a. A copy of the brochure from the manufacturer showing a picture & structure of the shed. b. A picture or sketch/plan of the proposed shed/structure

# Please submit all of the information outlined in this application checklist. If the application is incomplete, the application may be refused.
