A re-evaluation of the above-referenced property on the 9th day of July, 2007 revealed that the premise fails to comply with previous violation notices sent to you.

Attached is a list of those violations and re-inspection fees.

The property continues to be in violation of Article V. of the Housing Code of the City of Portland. A phone conversation on the 18th day of June indicated that you would have all violations (including the washer, dryer, trash, etc.) removed by the 23rd day of June, 2007.

All referenced violations shall be corrected within five (5) days of the date of this notice. A re-inspection of the premises will occur on 16th day of July, 2007 at which time compliance will be required.

This is a notice of intent to prosecute. The matter is being referred to the City of Portland Corporation Counsel for legal action and possible civil penalties, as provided for in § 6-1of the Code, and in Title 30-A M.R.S.A. § 4452.

Please be advised that because this is a letter of intent to prosecute, and that § 6.2 of the Code requires that you pay an additional \$75.00 re-inspection fee due to the repeated violations. This must be paid prior to the 16th day of July, 2007. Failure to pay the assessed fee within thirty (30) days shall cause the City to assess a lien against the property pursuant to § 6-1 of the Code.
