CONSENTED TO MOTION
TO CONTINUE

Pursuant to M.R. Civ. P. 16A, the City of Portland (the "City"), with the consent of the defendant, 87-89 Sherwood LLC ("Defendant"), moves to continue the dispositional hearing scheduled for December 12, 2016 at 10:00 a.m. until June 12, 2017 at 10:00 a.m. In support of this motion, the City further states:

1. The final dispositional hearing in this matter is scheduled for December 12, 2016.
2. Defendant has made progress towards remedying the violations alleged in the City's Uniform Citation and Summons, however, it will be unable to remedy all of the violations prior to the scheduled hearing date in this matter.
3. Defendant has committed to remedying the remaining violations by May 1, 2017, which plan the City agrees to.
4. To conserve judicial resources, the City requests that this Court continue the scheduled hearing, with the expectation that the City will be able to dismiss this case prior to the rescheduled hearing.
5. The City has been authorized to represent that Defendant consents to this motion.

WHEREFORE, the City of Portland, with the consent of the defendant, hereby requests that this Court continue the dispositional hearing currently scheduled for December 12, 2016 until June 12, 2017 at 10:00 am.


