There is a wooden post in the grass area (where registration is to take place). There are outlets on this post; they will be turned on and available for your use. You will need to keep tent stakes 3 feet away from either side of the underground electrical line. (please see the map – mailed to you on 8-14-06 - for locations of electrical box and underground cables). The tent must be positioned so that it (nor the stakes) interfere with the walking paths.

The map includes a "notent stakes allowed" area – the grass area will also be spray painted indicating where not to put stakes. Please make sure that the tent company knows this and keeps all stakes out of this marked area (please make sure they have a copy of the map).

A DIG SAFE does not need to be done as the area is already marked for electrical lines .

Any 10x10 canopies can be placed on the side grass areas. Your small free-standing 10x10 canopies do not need a permit.

The city takes no responsibility for your items that are placed on city property.

□ BATHROOMS / PORTA-POTTIES

If attendance at your walk exceeds 150 walkers, you are responsible for paying a \$25 porta-potty cleaning fee to P&R. Please follow up with me after your walk to let me know attendance at the walk.

There are currently 2 porta-toilets along the route (1 at the Preble Street Parking Lot and 1 at the Dyer's Flat Parking area near Payson Park).

The toilets are cleaned on M, W, F & Sat. If you would like to insure that the toilet is cleaned at the Preble Street Parking Lot on Sunday early morning for the start of your walk, you would need to call Margi at Blow Bros. (934-2525) and pay for that cleaning yourself - @ \$25; (P&R does not have a problem with you doing that).
