

- Client assumes responsibility to provide free and clear access for the installation/maintenance of all signage involved within this agreement.

- After manufacturing process has begun, project changes may incur additional fees.
- To begin the manufacturing process Bailey Sign Company requires a 50% deposit and a signed copy of this proposal and drawing.\*
- For your convenience you may pay by Visa, MasterCard or American Express. The following convenience fees apply and will be added to all orders above \$1,000: Visa and MasterCard: 2.5%, American Express: 4%
- Ownership of the signs will rest with Bailey Sign Company until final payment is made.
- Requisition invoices by the 25<sup>th</sup> of the month are payable in 10 – days.
- Warranties are void if invoices are not paid. *Warranties are one (1) year unless otherwise stated.*
- Bailey Sign Company reserves the right to remove signs in case of non-payment.
- Cancellation: A mobilization fee for work completed to date will be charged.
- Late payment interest rate, 18% annually along with legal / collection costs after 30 days delinquency.
