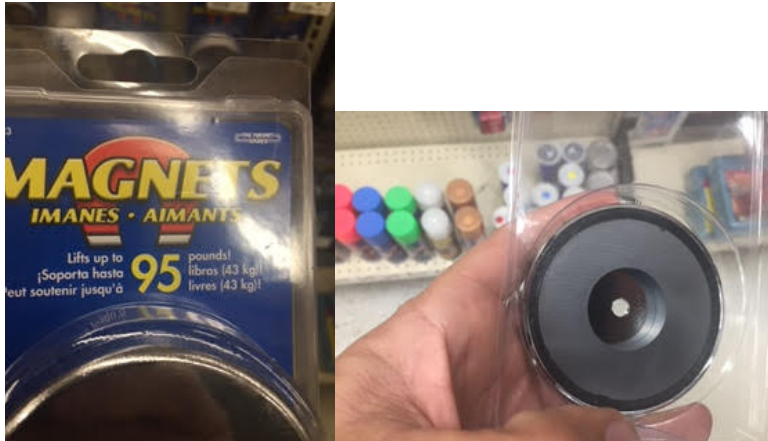

The sign is mounted on two 2x4's the long way by three wood screws per board and construction adhesive

Into the upper 2x4s we will screw two 3/4 by 1/4 lag eye bolts

On the corners of the container where there are distinct contact points we will loop 3/16 (800 lb rated chain) The chain will be connected by 3/16 (600lb rated industrial carabiners). The chain will be looped through the lag bolts and again closed by industrial carabiners)

In addition, we will mount 4 magnets on the back of the 2x 4's to eliminate sign sway.

Attached is a rough sketch.
