Dear Mrs. Allen:

As owner or agent of the property located at 42-Mg. Street, Portland, Maine, you are hereby notified that as the result of a recent inspection the entire vecent structure is hereby declared unfit for human occupancy.

The above mentioned structure is to be kept vacant so long as the following conditions continue to exist thereon:

a. The property is damaged, decayed, deteriorated, insanitary and unvafe (or vermin-infested) in such a manner as to create a serious hazard to the health, safety, and general welfare of the occupants or the public.

Therefore, you will not occupy, permit anyone to occupy, or rent the above mentioned without the written consent of the Health Officer or his egent, certifying that the conditions have been corrected. You are also hareby ordered to make the above mentioned property safe and secure so that no danger to life or property or fire hazard shall exist therein. This can be accomplished by boarding up all entrances and sealing all openings in the foundation.
