gives consent to the erection of a certain sign owned by

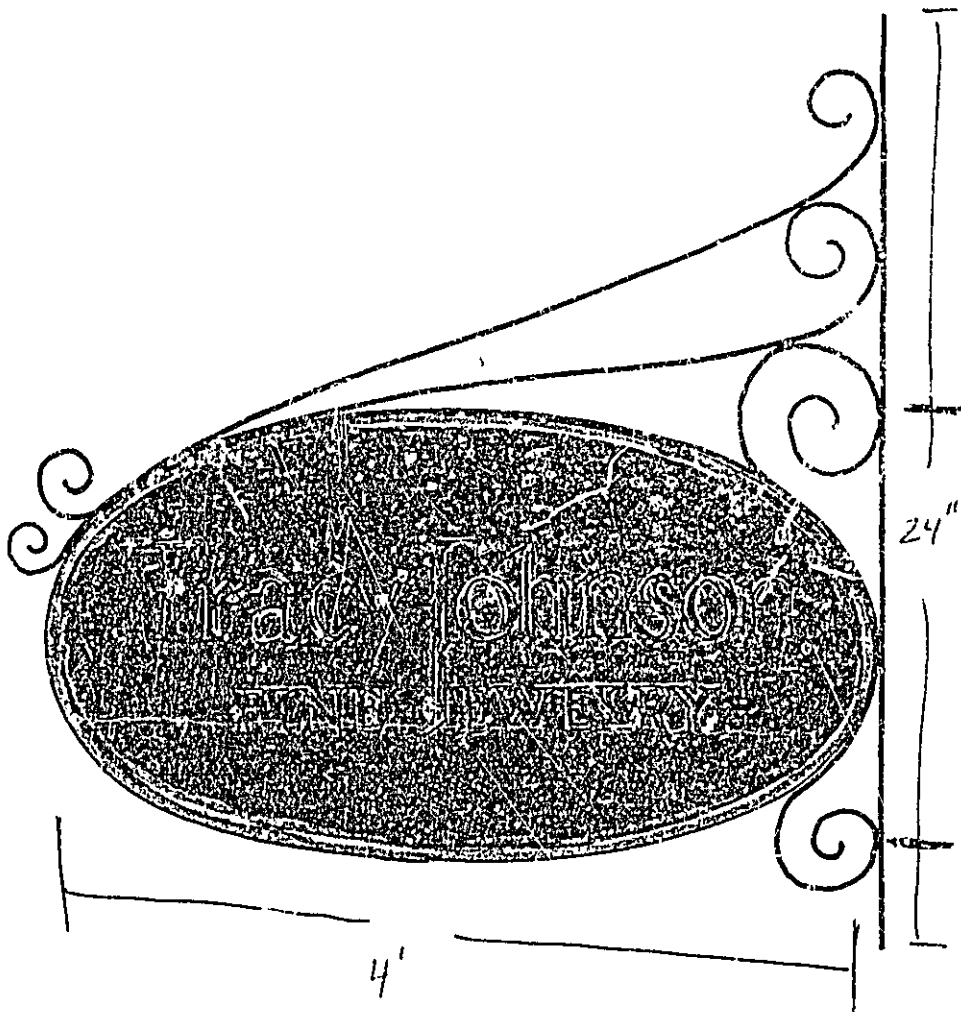
TRACY Johnson projecting over the public
