





This office is unable to issue permit to change the use of the third floor at the above building from a business office to a secretarial school with alterations as per plans because of the following exiting problems.

- 1. The front entrance door swings into the room, therefore if the occupancy of the school was to exceed a total of more than 50 persons at any one time, this door and all other doors serving means of egress would have to be changed to swing in the direction of exit travel. See Section 509.4.2.
- 2. The third floor has but one means of egress except an exit which is through a window onto a roof of a one story portion of the ruilding across this roof and then by ladder to the ground, contrary to Section 807.3: Stairways- A. Standard fire escapes shall extend full-width to the ground when used in (1) Theaters and Assembly Halls that accommedate more than 50 persons (2) Hospitals, Asylums, and Institutional Homes, or (3) Schools. Im other types of buildings, fire escapes designed to serve 50 or more persons shall extend full width to the ground or may be equipped with a counterbalanced stairway for the lowest run to the ground.
