I am fully aware of the arguments pro and con for the use of these gauges on cil stormes tenks. It is true that probably the rost of these gauges like those on automobile tanks are not reliable, but the invent of the Code is clear that they should as provided in order that the owner of the cil tank may not be compelled to remove a plug and sound with a stick in order to get come idea of how such cil there is in the tunk. This does not mean that you are prohibited from having such a plug in the top of the tank so that the driver of the cil supply truck say how positively how such oil there is in the tank and therefore how such he can put in. It seems, however, that opening the top of the tank should be confined to the times that the driver of the supply truck is forced to spon it to get an accurate knowledge of what is in the tank.
