We recently received a complaint and an inspection was made by Code Enforcement Officer Merlin Leary of the property owned by you at 126 Winter Street, Apt. #2, Portland, Maine. As a result of the inspection, you are hereby ordered to correct the following substandard housing conditions:

- * 1. KITCHEN CEILING - leaking. 108-2
2. KITCHEN & BEDROOM CEILINGS - buckled. 108-2

The above mentioned conditions are in violation of Article V of the Municipal Code of the City of Portland, Maine, and must be corrected on or before December 4, 1988.

Failure to comply with this order may result in a complaint being filed for prosecution in District Court.
