We will assume the repairs to be in progress if we do not hear from you within ten days from this date and, on reinspection within the time set forth above, will anticipate that the premises have been brought into compliance with Code Standards, Your cooperation will help this Department in its goal to maintain all Portland residents in decent, safe and sanitary housing. Repair the loose treads of the right rear porch stairs. Point-up the missing morter in the foundation overall. Repair the loose siding of the left front wall. Repair the loose treads of the right rear porch stairs. Repair the loose railing of the right rear porch. Repair the loose belusters of the right rear porch railings. 2. Replace the rotted posts of the right rear porch railings.

9. Papair the loose railing on the right front porch.

10. Repair the broken flour board of the right rear porch.

11. Replace the broken material on bulkheal on the loft rear door 12 .- Repair the rotted fence in the front yard.

Replace the broken stass of the living room window.

Replace the broken such cord of the living room window.

Replace the blogel-connection or correct the condition at the fixture the causes a cross connection at the tub in the bathroom.

Remove the publing paint of the rear bedroom calling.
