Your application to make interior renovations (office) has been reviewed and a permit is herewith issued subject to the following requirements. This permit does not excuse the applicant from meeting applicable state and place at laws.

No Committate of Occupancy will be issued until all requirements of this letter are met.

- 1. The fire alarm system shall be installed and maintained to NFPA 72 standards.
- 2. The sprinkler system shall be maintained to NFPA 13 standards.

  3. A portable fire extinguisher shall be located as per NFPA \$10. They
- will bear the label of an approved agency and be of an approved type.

  4. All exit signs, lights and means of egress lighting shall be done in accordance with Chapter 10, section and subsections 1023. and 1024. of the City's Building Code. (The BOCA National Building Code/1993)
