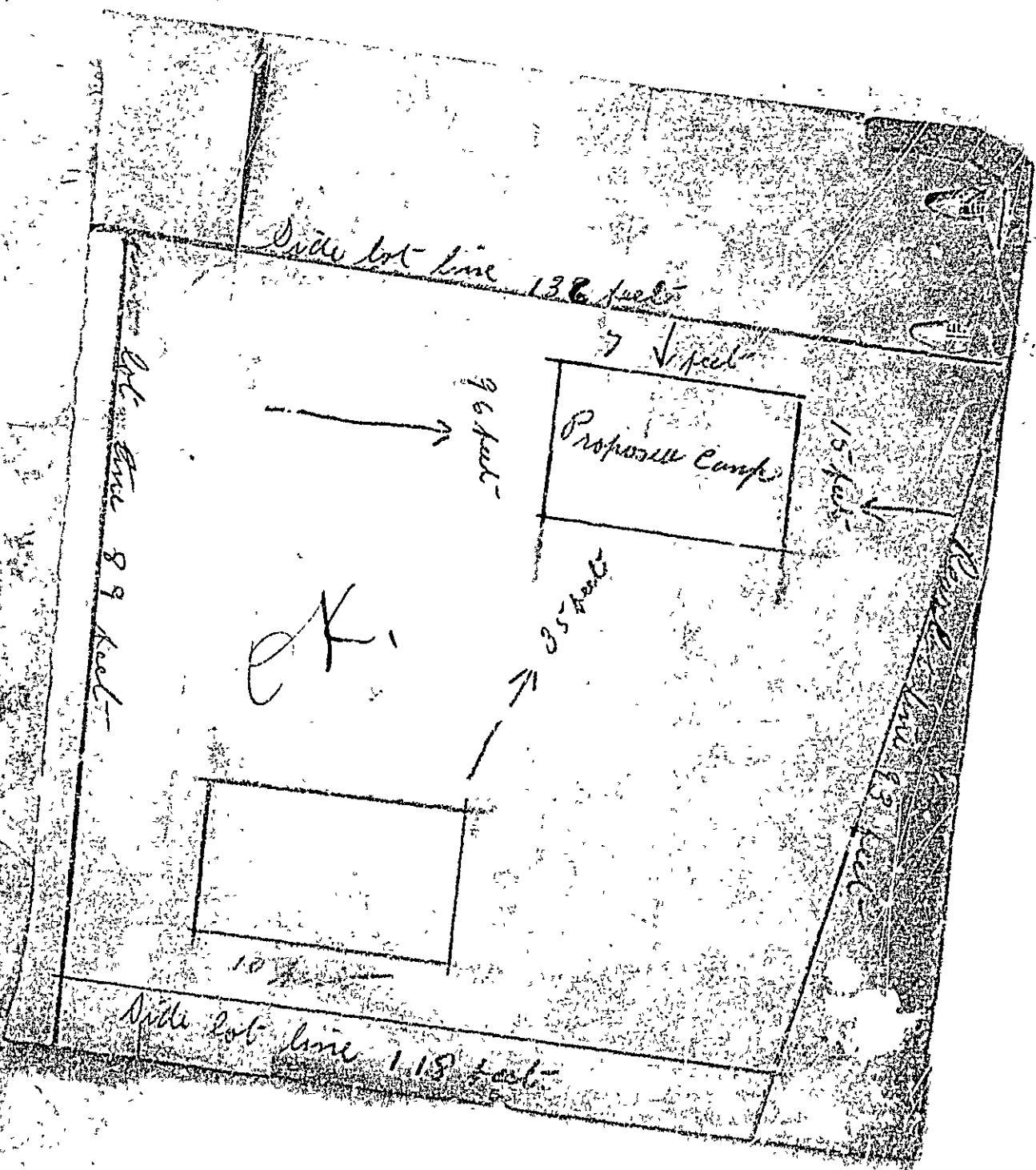
Your proposed building is located in an Apartment House Zone where an open space or yard of at least twelve feet is required between the extreme rear of the building and the rear lot line.

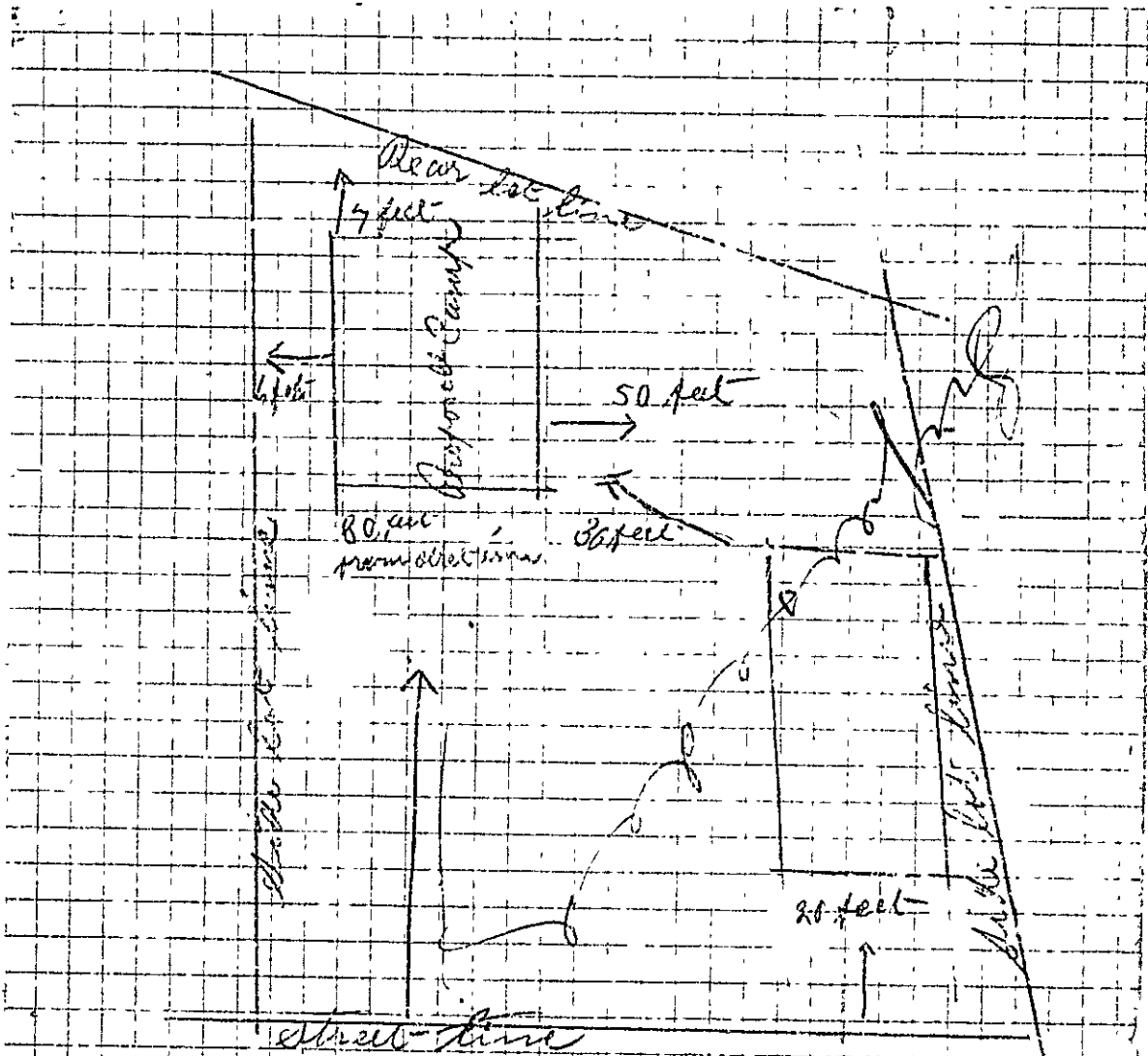
