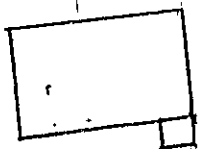

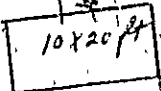

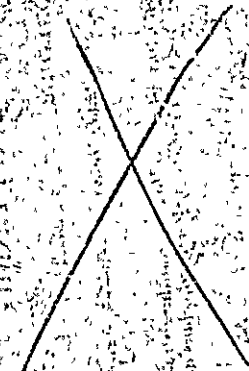

In the meantime it is unlawful for you to proceed with any of the work until the permit is actually in your possession.

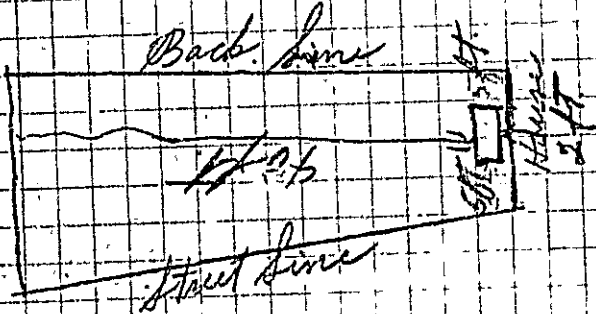

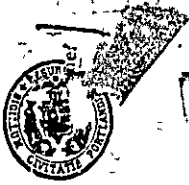
