Section 6 of the Ordinance for rodent and vermin control provides: "It shall be unlawful to demolish any building or structure unless provision is made for rodent and vermin eradication. No permit for the demolition of a building or structure shall be issued by the Building Inspection Department until and unless provisions for rodent and vermin eradication have been carried out under supervision of a pest control operator registered with the Health Department. The building permit for demolition cannot be issued until the provisions of this section have been satisfied. It is the obligation of owner or demolition contractor or both to take up with the Health Department the matter of complying with this section, being prepared to inform that department what registered pest control operator is to be employed. To Whom It May Concern:

The Committee on Zoning and Building Ordinance Appeals of the Municipal Officers will hold a public hearing at the Council Chamber, City Hall on Friday, December 13, 1940 on the appeal under the Zoning Ordinance of S. Mardigan relating to the use of the property at 1-7 Belknap Street.

The Inspector of Buildings is unable to issue a building permit to cover converting a portion of an existing private garage on this property for receiving and storing for a brief time certain quantities of baked goods to later be sold by the appellant at wholesale off the premises, because such a use of building or property is not allowable under the precise terms of the Zoning Ordinance in the General Residence Zone where the property 16 located.

The appellant has inadvertently been carrying on this use of the property for more than a year, and finding that the use is contrary to the provisions of the Zoning Ordinance, has resorted to his appeal rights under the Ordinance seeking a variance of the precise terms of the Ordinance in this particular case and supering that enforcement of the Ordinance involves an unnecessary hardship and that the proposed use of the property may be carried on without substantially departing from the intent and purpose of the Ordinance. In the meantime between the date of filing the appeal and the decision by the Appeal Board, the appellant has agreed to discontinue this use.

All persons interested either for or against this appeal shall be heard at the above time and place, this notice of hearing having been sent to the owners of property within 500 feet of the premises in question, as required

Paragraph c, of the Zoning Ordinance, on the ground that the enforcement of the ordinance in this case involves unnecessary hardship and because relief may be granted without substantially deregating from the intent and purpose of the Zoning Ordinance.

The decision of the Inspector of Buildings demiss a paral't to envert a portion of the existing private garage on this property for receiving and storing for a brief time certain quantities of baxed goods to later be sold by the appellant at wholesake off the promises, because such a use is not allowable under the Ordinance in the General Residence Zone where the property is located.

The reasons for the appeal are as follows: The appealant is in the theiress of selling baked goods from his truck to retail stores and a part of his baked goods comes from out-of-town. It would be a hardelip for him to provide some other place then his own property to receive these baked goods, and it is his bolish that this practice may be carried on without being objectionable or detrimental to the neighborhood.
