1. Repair or replace the faulty thermostat in the second floor apartment.

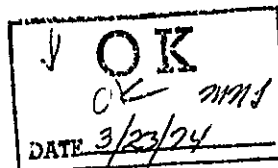
The above mentioned condition is in violation of Chapter 307 of the Municipal Code of the City of Portland, Maine and must be corrected on or before March 22, 1974.
