Dear Sir:

Please be advised that this office represents the residents of Prockside Road in Portland, Maine who are formally protesting the filling in of a natural waterway in the Baxter Boulevard area adjoining number 68h Baxter Boulevard.

This area more specifically being the basin where the orosk behind Brookside Road empties into the Eack Bay.

The rights to this property were recently purchased from Eugene Doone by Hazel Whitten. Hrs. Whitten, her agents, servents or employees have crossed the City owned property on Baxter Boulevard with heavy trucks loaded with fill and causing the same to be dumped in this basin.

This is in violation of the Revised Statues of the State of Maine 195h, Chapter 141 Section 6. If this is allowed to be continued, during the heavy rains of the spring and fall the brook will overflow onto the land of adjacent property on Brookside Road Causing irreparable damage.

Cur Clients object both to the filling in of this masin and the use of city property in order to accomplish the same.
