
1. Ties of at least 2x4 inch stock will be required at every third rafter at the plate level and hung in the center by a board to the rafters near the ridgeboard.
2. If, at any time in the future it is decided to close-in the breezeway a permit will be needed from this department. Closing-in would require fire separation between the garage and breezeway.



Permit to construct a 2-story frame dwelling 36'x23'4" is being issued subject to plans received with application and in compliance with Zoning Ordinance and Building Code restrictions as follows:

1. The setback of this house from the street shall not be less than twenty-five feet as measured from the street line to the front of the overhang.
2. The corner posts are to extend in one piece with 18-inch lap splices allowed from either the solid sill or from the first floor shoe (sole plate) where a box sill is allowed to the double plate which supports the roof rafters at the eave level. The second floor studs in the exterior walls are to extend down to the double 2x4-inch plate upon which the second floor joists rest with the second floor joists being spiked to these studs. In a garrison type overhang the studs and corner posts may rest upon the 2x4 inch shoe of the second floor.


