You may consider this letter as a temporary certificate of occupancy for your new dwelling at the above location.

The only matter that is holding up the issuance of the final certificate in in relation to the framing and supports of the platform on the rear of the house. This structure has been rade about $6! \times 11!$ in size instead of $3! \times 5!$ as shown on plans. In the first place the pipe columns at the corners of the platform have an outside diameter of only one and three-quarter inches whereas the minimum set by the Building Code is 3!.

The 2x6 floor joists spaced 24" on centers will not work out unless placed not more than 16" on centers and are required to be notched over no less than 2x3 mailing strips spiked to the sides of the 4x6 sills instead of being toe-mailed into the sides of them as has been done.

All of these details must be adjusted to comply with Building Code requirements before issuance of final certificate. Please have this matter attended to as soon as possible and notify this office for another inspection so that we may clear this job from our records.
