In accordance with Title 25, Revised Statutes of 1964, a Supervising State Fire Inspector recently inspected your property and found the following conditions in violation of the statutes governing the fire laws of this State, as indicated below:



Discontinue the use of plastic waste barrels. Hutal barrels with covers to be provided.

Discontinue the use of wedges under fire doors in kitchen. 2% doors are to be hold open; electro-sugnetic holdbacks to be installed and inter-connected to the sprinklar system or smoke detector mounted in kitchen.

Please advise this office in writing when such violations of the fire laws have been corrected in order. that this office may advise the Commissioner of the Department of Health and Welfare that your property complies with the statutory provisions relating to fire safety.

Gentlemen:

Permit for the above work is issued herewith, subject to the following:

It is understood that the State requirement that all exit doors shall swing outwards, includes the front entrance doors and perhaps the exterior doors at either end of the first floor. It is likely that swinging these doors outwards would mean that there would be a step down under the outward swing of the door. If that is the case, a day to day accident hazard would be set up well recognized by Listility Insurance people. While we have nothing in the Building Code which specifically forbids such a situation, it is suggested that these responsible for the Home may desire to contact the Director of Fire Provention in Augusta to see if he would not prefer to leave these doors which are used right along for antrance and exit also, as they are, rather than subject to people using the doors regularly to this well recognized accident hazard of only one step at a single spot and that under the outward swing of a door.

The plan with the application indicates that there is to be installed a manual fire alarm system. If it is truly a manuel system, no separate permit for its installation is required from this department; but, if it should turn out that this system is automatic, a separate permit from this degariment is required, that permit to be applied for by aff issuable only to the actual installer.

It appears that the upper landing of the upper wooden part of the fire escapes on each end of the building, evidently having been there for many years, was supported in an unusual way when the platforms were built, S'a in that the only support seems to be the run of stairs downward and the bearing of the platform joists on the roof of the building. Since these platforms are ovidently fairly old, it is recommended that the Home have them thoroughly examined and if they do not appear to be permanently safe to take stops to make them so.

It is noted that the concrete baues for support of the bottoms of the new stairways, which are required by law to extend not less than four fect below the surface of the ground, are to be surplied by someone other than the contractor for the metal work. We wish to call attention that such footings are required by the Euliding Code and that provision of them chould not be overlooked.
