- 1. The 6x8 girder, if of hemlock or spruce lumber, Jo-wal adll need to be full size rather than drossed in Gyfda DTT. order to figure out on the spans indicated.
- 2. The 2x6 dressed fir rafters on a horizontal span of 15. feet will not figure out unless spaced no more than 14 inches instead of 16 inches on centers no fit 240 c which will mean that coiling timbers should be spaced in same manner in order to provide a good tie across building. However, if 2x6 fir rafters were used, they could be spaced 24 inches on conters. Please furnish information before notification is given for check of forms as to which you will use.
