Pursuant to the provisions of Title 38 M.R.S.A. Section 1301 et seq., and 06-096 CMR Chapter 405, Solid Waste Management Rules, effective May 24, 1989, the Department of Environmental Protection has considered the application of TILCON MAINE, INC. with its supportive data, staff summary, and other related materials on file and FINDS THE FOLLOWING FACTS:

APPLICATION SUMMARY

- a. <u>Application:</u> The applicant has applied for batch approval of a special waste.
- b. <u>History:</u> TILCON MAINE, INC. (TILCON) operates a batch plant on Bishop Street in Portland, Maine that produces hot bituminous concrete. Department Order #S-23615-WK-A-N, dated May 2, 1991, approved the use of spent blast grit by TILCON in the manufacture of bituminous concrete. The spent blast grit is substituted for native aggregate in the batching process. Under the current license conditions, TILCON may only accept spent blast grit from Bath Iron Works and Portland Pipe Line Corporation.
- c. <u>Summary of Proposal:</u> TILCON requests approval for the one time disposal of approximately 42 tons of spent blast grit at the Bishop Street batch plant. The material was generated by International Paper during the removal of epoxy paint from the interior surface of a storage tank.

2. TECHNICAL SUMMARY

a. <u>Review:</u> Department staff have reviewed the batch analytical data and found the material to be acceptable for disposal.
